Julie Bleicher, Hannah G. Solomon Awardee 2018

From Emerging Leader (1995) to Hannah G. Solomon Awardee (2018), Julie Bleicher has been a go-to person for NCJW for 25 + years and counting. Julie has ably dedicated her keen intellect, strong work ethic and commitment to NCJW's mission and healthy functioning to a wide variety of leadership roles, including, to name a few: Treasurer, Administrative Vice President, Event Co-chair, Finance Committee Chair, and, currently, Strategic Plan Co-chair. And she undertakes these and other responsibilities with a delightful and endearing sense of humor.

While always being "there" for NCJW, Julie has also been a leader in numerous other community organizations, many of them focused on the wellbeing of women and children. She has been Chair of the board of the Dallas Women's Foundation, which recognized her with its Maura "Women

Helping Women" Award in 2015, and she currently serves on the boards of Girls, Inc. (where she has been Treasurer), the Dallas Summit (President-Elect), and Temple Emanu-El. She also served on the board and Executive Committee of Greenhill School, where she led one division of the school's successful first capital campaign.

Julie also has wide experience in the for-profit world (computer systems design, human resources) and recently retired after 12 years as Administrative Manager of the Tessitura Network, the leading software company for arts and cultural organizations.

What motivates and energizes this remarkable woman? Julie grew up in a small community in western Maryland (part of Appalachia) where hers was the only Jewish family. Julie's late mother, Sara Claster Mamolen, was probably unaware of NCJW or of Hannah G. Solomon but her community activism instantly brings our organization and its founder to mind: A teacher before she married, Sally founded the town's first kindergarten, first free medical clinic and first volunteer reading program at the public library, as well as undertaking other initiatives to improve the quality of life in the community. Julie credits her mother as her role model "whose work informed and inspired my own interests and leadership as an adult."

In the spirit of her mother, Julie says that as she became an active volunteer, "I found myself gravitating primarily to groups and causes that help women and girls." She joined NCJW at the invitation of Ellen

Silverman and Maddy Unterberg and the first project she worked on was Paths to Prevention. Julie was inspired by this initiative and its goal of forming a public/private partnership to address the problem of teen substance abuse. As she learned more about NCJW she felt aligned with its history and priority issues.

Julie applauds NCJW's current push to become a more sustainable organization and is pleased to be a part of that effort. As Finance Committee Chair, taking the organization through financial and budgeting reorganization, she found satisfaction in increasing the board's awareness of the importance of financial sustainability.

In addition to her mother, Julie cites her friends Cecilia Boone (NCJW Pioneering Partner Awardee 2012) and Suzi Greenman (NCJW Dallas

Executive Director) as heroines whose strong leadership qualities have motivated and taught her in her community involvement. Julie describes herself as "helping make change primarily through collaborating with others, rather than by always having an individual leadership role. My skills help organize projects, and I think I help keep groups focused and on track to accomplish goals."

Julie's advice to aspiring leaders: "There is always a way in. I truly believe that part of my success is that I was perhaps naïve enough to just jump in and assume my efforts would be welcomed. Truthfully, they generally were. I would also say — 'don't think about being a leader, think about helping get the work done.' Leadership will follow, I promise."

Julie has a B.A. from Chatham College (now Chatham University) in Pennsylvania and an M.B.A. from Southern Methodist University She is the proud mother of two grown sons and a daughter-in-law who live in the Chicago area.

Janis Levine Music Make-A-Difference Award: Judy Hoffman



Judy Hoffman, a dedicated volunteer who works tirelessly for the good of others while resisting recognition for herself, is the recipient of the National Council of Jewish Women, Greater Dallas Section's 2018 Janis Levine Music Make-A-Difference Award. This award honors the memory of Janis Levine Music who gave of herself with dignity and kindness of spirit and is given to an individual who makes a difference wherever she serves. Judy grew up in a family that understood and

appreciated the value of service. Her father, Joe Lautin, was born in Europe and experienced first-hand the challenges -- often tragic -- of hatred, genocide, immigration and poverty. He joined the United States Army as soon as he was able and at the conclusion of World War II, he worked hard to arrange the transport of his surviving brother and sister from the devastation of post-war Germany. Judy's mother, nee Devora Juster, enjoyed a middle class Midwestern upbringing. Her father was a lawyer who, during the depression and other times as well, accepted trade skills and services as commercial barter.

Growing up in a family that was progressive socially and politically, Judy took for granted that her interest in service and 'fairness' were universally shared and was surprised, as a teenager, to personally witness anti-Semitism and other overt signs of racial and economic discrimination. That, of course, served as not only an objective lesson in the wide range of attitudes regarding these matters, but also as a personal call to stand up, speak out and act accordingly.

Some of Judy's earliest opportunities for volunteering were created by her mother, who served as an unpaid advisor to the Shearith Israel branch of United Synagogue Youth. Judy regularly tutored children at a West Dallas recreation center and served as a juror on Teen Court. As USY Community Service Chair, she planned and executed projects throughout the community.

Judy first attended Dallas public schools and graduated from The Hockaday School. She earned a Bachelor of Arts degree in Economics and Statistics from Bryn Mawr College. Judy started her career in consulting, specializing in compliance with federal employment discrimination regulations; worked in personnel for Johnson & Johnson and transferred to its subsidiary McNeil. She was Human Resources Director for the developer of Las Colinas and, later, for Trammell Crow Company. For the past 10 years, she has provided consulting services to select employers and organizations.

In the community, aside from work with the American Red Cross, Judy contributed her time to St. Mark's School of Texas, Golden Acres, and Prestonwood Elementary School. She continues to collect and coordinate the distribution of donations from Whole Foods Market to a variety of local charities including the Vickery Meadow Food Pantry, Aids Outreach Center, Bryan's Place, and Promise House.

Currently, she is working at Caregivers Day Out at Temple Shalom as well as the afore-mentioned Vickery Meadows Food Pantry and Kids in Court.

Judy met her husband Joel at Shearith Israel Sunday School when they were 16 years old. They have two sons, Ben and Dan, one granddaughter and one grandson.

Erin Zopolsky – 2018 NCJW Emerging Leader Award

The NCJW 2018 Emerging Leader Award recipient is Erin Zopolsky, an engaging and talented woman who lights up the room with her energy and commitment. She is a shining star, yet so humble about her contributions — as Erin says, "How can I be proud of something that I should be doing?"



Erin grew up in Baton Rouge, LA and went to Stephen F. Austin College where she studied Hospitality Administration. Upon

graduation she moved to Dallas to work in a Management Training Program at the Four Seasons Hotel, and then continued her career for a decade in medical event planning. She is married to Dallas native, Joe Zopolsky, and they are the proud parents of Hattie (4) and Jay (7). Erin is an active member of the Parents Association at both her children's schools.

When Erin came to Dallas, she was drawn to projects that empower women. At that time, she concentrated her energies on volunteering for Dress for Success, an organization that focuses on dressing women in business attire and prepping them for job interviews. More recently Erin has served as President of the Temple Emanu-El WRJ/Sisterhood and is currently on the Board of Trustees at Temple Emanu-El.

Four years ago Erin attended an NCJW event that featured a speaker on health care and social justice. The event resonated with Erin — she saw NCJW as a bright group of women using their resources in a positive way to better society and empower women, and she wanted to be a part of the organization in a more meaningful way. Ever since that event, Erin has fast—tracked her involvement with NCJW. Erin chaired the 2017 NCJW Awards and Installation event and is on the Host Committee for the 2018 Birthday Luncheon. Additionally, Erin serves on the NCJW Board of Directors and is currently the Co-Vice President of Fund Development.

Although Erin enjoys producing "big events" where she can tap into her professional expertise, she also likes participating in one-on-one projects that directly touch people's lives, such as the West Dallas Back to School Fair. Erin is an impressive young woman, and we look forward to her sharing her myriad skills, passion, and enthusiasm for years to come with NCJW.

How Do You Raise a Mensch?

How do you raise a family of mensches? A family who gives and gives to the community? A person who gives both monetarily and in time and passion to repair a broken world? Members of NCJW Dallas needn't look very far for an example. NCJW Dallas Past President, Honorary NCJW National Board Member, and Past Board member of the NCJW Research Institute for Innovation in Education (RIFIE) at Hebrew University Jerusalem, Bette Miller and her family members are a shining example of how it's done.

Bette's grandfather Kalman Wolens came to the United States from Poland in 1893. The family landed first in Chicago. In 1896, after a previous trip to Texas failed, Kalman, returned to Texas with his three sons, Max born in Poland, and Louis and Joe, (Bette's father) born, in Chicago. The family's only girl, Daisy, was born in Corsicana, Texas. No doubt this small Navarro County Town was quite foreign to this Polish Jewish family, but they seized the opportunity, starting their mercantile career on a side street sidewalk selling spectacles, eventually building the successful K. Wolens Department store chain. At its peak, the forty six stores served small farming communities throughout east, central and south Texas. As the business grew K's children each took their place running different departments in the business.

The family was involved in the community, serving on the board of Camp Fire, the Chamber of Commerce, the PTA and founding their communities' synagogue. The family even had a mikvah in their home to serve the Jewish community. Bette remembers discussions supporting all minorities and the rights of women, not always easy discussions in a small Texas town of another era.

When asked how they became such a charitable, involved family, Bette said that the example set by her parents and grandparents was all they needed. Repairing the world was not necessarily discussed, but because of the many activities in which the family was involved the children and grandchildren learned by example.

Bette and her late husband Bennett also led their children by example. During the three years Bennett was the executive director of the "War on Poverty", he often brought his children with him as he worked on community projects and when he volunteered in NCJW's West Dallas study center. The girls also went with Bette to the NCJW office to stuff envelopes and work on other service projects.

Bette's father died when she was 13. Her Uncle Louis had no children, but was always there for Bette, giving her away when she married Bennett. When Uncle Louis died in 1980 he stipulated in his will that a foundation be established honoring his parents Kalman and Ida Wolens. In addition, his will designated that \$300,000 from his estate be designated for a program in Israel. Bette's love of NCJW and the families' support of Israel drove the gift of \$300,000 from Louis' estate through NCJW to establish the Louis and Ann Wolens Chair in Educational Research at Hebrew University in Jerusalem.

Several members of the family have chaired the Wolens foundation starting with Dean Milkes as its original president, then his daughter Cheryl Moore and since 2010, Bette's nephew, Joe Milkes. Bette has been an officer of the Foundation from its inception. The Foundation's original mission included supporting Israel and Navarro County and the foundation still supports programs in Corsicana and Israel.

NCJW Inc.'s programs in Israel have long been supported by the Wolens Foundation; this past year the NCJW Israel program was

able to expand adding personnel both in New York, and a part time person in Israel due to the generosity of the Wolens Foundation.

When asked why NCJW, Bette laughed and said she was hounded by several groups when she first moved to Dallas in 1959, but her interests were not only Israel, but also giving back to the broader community in which she lived. Bette's "address" she says is community service. Her first assignment with NCJW was chair of decorations, and then she was quickly asked to be Vice-President of Public Affairs, Ways and Means, Community Service, Executive VP and then President of our section. Bette served as Southern District President, when National had Districts, served as a National Board as member and recording secretary, and on the RIFIE Board in Israel.

NCJW Dallas has been supremely gifted by the Wolens Foundation in the last two years because of Bette's passion and her nephew Joe's belief in the mission of NCJW. In each of the last two years, the Foundation has granted NCJW Dallas money for capacity building so we can continue for the next 105 years!

When asked what she was most proud of in her years in NCJW, Bette replied that leasing the building on Harry Hines for both Encore and the Section office, and bringing new program ideas to our Section, including the Community Board Institute. But as a detailed research oriented person, Bette says she will have the most pride when the NCJW Dallas history book, on which she has toiled for the past 5 years, is finished. Bette is our living history; how fortunate we will all be to have our own history book thanks to her amazing efforts along with Marlene Cohen and Rosie Stromberg. Bette has contributed to NCJW Dallas' proud history in countless ways, but the creation of the Centennial History Book ensures that her legacy of service will live on for many decades to come.

Freda Gail Baum Stern 1930 - 2017

Freda Gail Baum Stern died of a heart attack on July 17th at the age of 87. A Dallas civic leader and public relations executive who founded her own firm at a time when women were a rarity in the industry; Freda Gail defied the odds and built her company. It grew to represent local, national and international clients including Chrysler Corp., Miller Brewing, Elizabeth Arden, Sheraton Hotels and Kaiser Permanente.

Throughout her life, Freda Gail gave freely of her time and expertise to many worthy causes and organizations. We are fortunate that National Council of Jewish Women, Greater Dallas Section, was among those organizations. Freda Gail was an admired and highly esteemed member of NCJW Dallas for over 50 years. She was a long-standing "go to" advisor to whom we turned when stymied. In the last several years, Freda Gail and her close friend. Hanne Klein, served as "Assistant Editors" of The Bulletin, working behind the scene to ensure that articles were well written and relevant. Only last year, she played a key role in counseling the Centennial History Book Committee on the best way to have their book produced.

It is especially meaningful that Freda Gail found NCJW Dallas worthy of a bequest. A strategic thinker of the highest order, Freda Gail understood and appreciated the importance of having a healthy endowment to ensure the financial stability of NCJW --now and in the future. In accordance with a policy established by the Board of Directors in 2010, Freda Gail's beguest of \$26,000 has been placed in the NCJW Dallas Endow fund where it will grow and help provide a reliable source of revenue for NCJW's programs and services.
